Players who have not met their financial obligations to their current team/club will not be approved for drop or transfer until all financial matters are settled.

- 1. The player is required to complete the online release form at: https://www.gotsport.com/forms/open/?FormID=1365
- 2. KSYSA & the player's current club are then contacted when the form has been submitted.
- 3. The club has 7 days to Approve or Deny the request, if denied- please comment why the request was denied.
- 4. KSYSA will then Approve or Deny the request.

Transfer will not be completed until registrars finalize the actions needed.

This includes:

- The submission of this form with all signatures (approvals) intact.
- The submission of the current player card to the registrar whose team/club you are leaving.
- Approval of the current registrar.
